Based on the above schedule, please find the bus assigned to your address and then choose the stop that is closest and safest for your child(ren). For safety reasons, it is imperative that your child(ren) rides only on their ASSIGNED bus, and rides to and from school on the same bus.

Students are to wait on the sidewalk, until the bus comes to a complete stop, initiates its red lights, and engages the safety gate.

All busses are running close to maximum capacity. Please instruct your child(ren) to:

- Quickly find a seat and move all the way in toward the window;
- Place all backpacks, lunch bags, etc. on the floor or on their lap to allow sufficient seating for other students;
- Buckle their seat belts.

Students are NOT ALLOWED to stand or sit on the floor of the school bus.

For early dismissal and delayed openings, please consult the student/parent handbook and adjust the pick-up and drop-off times accordingly.
